**TODAY'S READING'S**

**Reading 1 Is 45:1, 4-6** - Thus says the LORD to his anointed, Cyrus, whose right hand I grasp, subduing nations before him, and making kings run in his service, opening doors before him and leaving the gates unbarred: For the sake of Jacob, my servant, of Israel, my chosen one, I have called you by your name, giving you a title, though you knew me not. I am the LORD and there is no other, there is no God besides me. It is I who arm you, though you know me not, so that toward the rising and the setting of the sun people may know that there is none besides me. I am the LORD, there is no other.

**Responsorial Psalm Ps 96:1, 3, 4-5, 7-8, 9-10**

**R. Give the Lord glory and honor.**

Sing to the LORD a new song; sing to the LORD, all you lands. Tell his glory among the nations; among all peoples, his wondrous deeds.

**R. Give the Lord glory and honor.**

For great is the LORD and highly to be praised; awesome is he, beyond all gods. For all the gods of the nations are things of nought, but the LORD made the heavens.

**R. Give the Lord glory and honor.**

Give to the LORD, you families of nations, give to the LORD glory and praise; give to the LORD the glory due his name! Bring gifts, and enter his courts.

**R. Give the Lord glory and honor.**

Worship the LORD, in holy attire; tremble before him, all the earth; say among the nations: The LORD is king, he governs the peoples with equity.

**R. Give the Lord glory and honor.**

**Reading 2 1 Thes 1:1-5b** - Paul, Silvanus, and Timothy to the church of the Thessalonians in God the Father and the Lord Jesus Christ: grace to you and peace. We give thanks to God always for all of you, remembering you in our prayers, unceasingly calling to mind your work of faith and labor of love and endurance in hope of our Lord Jesus Christ, before our God and Father, knowing, brothers and sisters loved by God, how you were chosen. For our gospel did not come to you in word alone, but also in power and in the Holy Spirit and with much conviction.

**Gospel Mt 22:15-21** - The Pharisees went off and plotted how they might entrap Jesus in speech. They sent their disciples to him, with the Herodians, saying, "Teacher, we know that you are a truthful man and that you teach the way of God in accordance with the truth. And you are not concerned with anyone's opinion, for you do not regard a person's status. Tell us, then, what is your opinion: Is it lawful to pay the census tax to Caesar or not?" Knowing their malice, Jesus said, "Why are you testing me, you hypocrites? Show me the coin that pays the census tax." Then they handed him the Roman coin. He said to them, "Whose image is this and whose inscription?" They replied, "Caesar's." At that he said to them, "Then repay to Caesar what belongs to Caesar and to God what belongs to God."

**Reflection:** - The Pharisees and the supporters of Herod approached Jesus with a tricky question: "Is it lawful to pay the census tax to Caesar or not?" Because the Emperor of Rome demanded of each of his subjects should pay tax to the government. Those who had attained the age of 14 (man), 12 (woman), and up to 65 years were obliged to pay.

Jesus answered them, "Repay to Caesar what belongs to Caesar and to God what belongs to God". If Jesus would say YES, the people would resent and reject Him because no Jew likes to pay taxes especially to the foreign Roman government. For the Jews, it is an insult to their religion and a blasphemy against God because they held that only Yahweh is their King. Their nation was a theocracy and to pay taxes to an earthly king was to admit the validity of his kingship and thereby to insult God. Therefore, if Jesus answered "yes" they could bring people against Him.

Jesus here wants to give a clear message to them and to us now. It is a moral and civic duty to contribute to the common good with the payment of tax. No reason can justify tax evasion or theft of state assets. Whatever the policy and economical choice of the government, the disciple of Christ is called to be an honest and exemplary citizen. They are actively engaged in building a just society.

On the other hand, if Jesus says NO, the Pharisees would report Him to the Roman government as a revolutionary person or an insurgent. The Roman government would then arrest Him and put Him into prison. But Jesus did not bite their trap on Him.

Jesus' answer acknowledges not only our obligation as citizens to the state but affirms our larger obligation to God. We give to the emperor the coin because his image is on it, and we give to God our own selves because we are created in the image of God (Gn 1:26). If the coin had to be 'returned' to Caesar because it was stamped with the face of emperor, the people must be 'returned' to God. The human being is the only creature on whom the face of God is imprinted.

Continued- Both the state and God require certain loyalties from us, but we owe God our very lives.

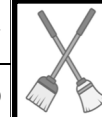
